**Re: California Proposition 65 Warning Requirements – Your response is requested**

Dear Valued Customer,

At Wausau Supply, we are devoted to the health and safety of our customers. We are committed to conducting business in a socially responsible and ethical manner consistent with applicable national and local laws. As you may know, California enacted the Safe Drinking Water and Toxic Enforcement Act in 1986; commonly known as Proposition 65 (“Prop 65”). Under Prop 65, manufacturers, distributors and retailers making sales to customers in California are required to give a “clear and reasonable warning” for products containing one or more chemicals on the Prop 65 chemical list. A few example chemicals from the list include Aloe Vera, Lead, Tobacco smoke, Alcoholic beverages, and Wood dust. Wausau Supply is committed to compliance with Prop 65 and have added a warning to the bottom of each invoice to ensure continued awareness. Due to the nature of your business and this requirement, you too may be obligated to comply with Prop 65 warning requirements. Retailers who sell and/or distribute products into the stream of commerce in California are required to post a warning sign displaying “either at the point of sale or display of the products in a manner likely to be seen by the purchaser.” §25607.10. Additionally, Internet sellers must provide product-specific Prop 65 warnings on their website (on the product display or prior to the completion of the purchase), for all products for which a Prop 65 warning is required.
